# Standard deliveries

- Standard retail store
- Business customer's warehouse as the only valid delivery location + V-ZUG's standard route planning (e.g. twice a week)
   Project business/construction site delivery (new buildings or renovations) with ≥ 4 units per delivery

# Additional services provided by our transport department

Special requests and additional services for our customers are associated with additional effort and costs. Therefore, we would like to point out the additional costs with this document and ask you to take note of them.

#### **Special delivery**

There is no entitlement to special delivery. V-ZUG tries to adapt delivery route planning to customer requirements if possible.

# Delivery of small quantities directly to the construction site

• CHF 170.00 for 1-3 devices

#### Distributing the devices on floors and/or apartments

- Effective costs will be communicated by V-ZUG in advance
- The transport service must be agreed by the business customer together with V-ZUG in good time, at least 5 working days before the planned delivery

#### Return of packaging material (cardboard and polystyrene)

- V-ZUG does not unpack any appliances on site at the business customer's premises
- Standardised packaging and pallets can be returned by the business customer on the occasion of the delivery of products by V-ZUG, provided that they are in an unsoiled condition and are provided separately according to materials
- There will be no separate collection by V-ZUG and any return will be at the expense of the business customer
- A larger quantity of returned packaging and pallets must be notified to V-ZUG in good time, at least 5 working days before the planned return
- V-ZUG can charge business customers the value of non-returned, standardised packaging and pallets at cost
- Non-standardised packaging will not be taken back

## Return of one or more devices

If V-ZUG or a third party commissioned by V-ZUG has caused the incorrect delivery of appliances, business customers can return the appliances free of charge.

If the incorrect delivery was caused by the business customer, the return will be invoiced by V-ZUG.

Handling charge:

- for 1-3 devices flat rate CHF 150.00
- from 4 devices CHF 50.- per each additional device
- Damage to the device caused by the business customer will be deducted from the refundable amount (at least 10.0% of the original net price)

In any case, returns are only permitted within the first two months after delivery. The devices must be unused and in their original packaging. An additional CHF 50 per device will be charged per open package.
